

OL PEJETA CONSERVANCY CODE OF CONDUCT



Strict speed limit of maximum 40 kph.



Do not discard litter or cigarette butts.



Off road driving is strictly prohibited (unless approved by management). Keep to designated roads or tracks.



Beware of dangerous wildlife and do not get out of the car unless in a designated area. Remember you are food.



Wildlife always has right of way. Do not chase, follow or harass animals.



Do not feed wildlife from your car, in the wild or at your camp or lodge.



Do not sit or stand on vehicle's roofs at any time.



Collection of firewood is prohibited.



Please do not damage or remove any flora or fauna, including bones and plants.



No driving on the Conservancy is allowed after 7pm.



No firearms, spears, bows and arrows of any kind are to be carried within the Conservancy.



Please ensure that you obtain an official receipt for any cash transaction.



No use of private drones unless authorised.



Please respect our Code of Conduct and our rangers, who are there to ensure

the protection of the wildlife and the environment. Rangers have the legal right to:

- Impose a fine of Ksh 5,000 per person for anyone caught breaking the Code of Conduct
- Have a vehicle and/or people removed from the Conservancy immediately
- Have a vehicle and/or people banned from the Conservancy

RELEASE, DISCHARGE, AND ASSUMPTION OF RISK AND WAIVER

I fully accept that by my entry into OI Pejeta Conservancy (“The Conservancy”) for any purposes whatsoever there exists inherent danger to my life and property.

I confirm that I have read the Conservancy’s “CODE OF CONDUCT” and that I shall abide by it in order to be safe, secure and aware of any potential risks.

I confirm that I have read and agreed to the Conservancy’s “LEGAL DISCLAIMER FORM”.

I understand and accept that there are dangerous wild animals (including lions, rhinos, elephants, buffaloes, snakes, insects and others) within the Conservancy and I accept that by entering into the Conservancy for any purposes whatsoever, I agree to waive and release the Conservancy, OI Pejeta Conservancy Limited and any of its directors, employees, agents, affiliates and officers and to hold each of them harmless from all and any injury, liability, claim, accident, loss or damage of any nature that may arise as a result of my entry onto the Conservancy including but not limited to personal injury (fatal or otherwise) and / or that may be caused to my personal property.

This waiver is entered into on my behalf and on behalf of any minors (under the age of 18 years) accompanying me, and is binding on my assigns, heirs and legal representatives.

I confirm that this waiver shall be interpreted broadly to provide a release and waiver to the maximum extent permissible under Kenyan law.

If any portion of this waiver is unenforceable, such portion shall be struck out provided that the remaining portion shall remain in full force and effect. This waiver shall be governed by Kenyan laws.
